For each of the countries involved, a comparison has been carried out between the local arbitration law and the UNCITRAL Model Law approved by the United Nations in 1985. The English language text of this Model Law has then been compared with the local language text of the arbitration law of each country and any discrepancies have been investigated in order to identify possible differences in the legal cultures underlying the two texts.
